Sub: Compulsory fill up and submission Residential Tenants Verification Form (Mandatory U/S 223 of BNS)

I am enclosing here with the order passed by Ld. Commissioner of Police, Bidhannagar Police Commissionerate in c/w Tenant Verification along with Tenant Verification Form for wide circulation at your area. The order directs that:-

- 1. No land-lord or owner or person whose property falls under the jurisdiction of area of any of the Police Stations under Bidhannagar Police Commissionerate area shall let/sublet/lease/rent out any residential accommodation or grant lease or license to any person unless and until the said landlord/owner/person has furnished the particulars of the said tenant(s)/license as the case may be as per the Proforma in Schedule-I to the Officer-in-Charge of the Police Station concerned.
- 2. Whoever having property in his possession or under his management shall also infom in writing to the Officer-in-Charge of the Police Station concerned in whose jurisdiction the premise falls about the particulars of the tenants or leasee or licensee as the case may be as per the said proforma within 07 days of the tenant agreement.
- 3. Any person contravening this order is liable to be punished under Section 223 of the Bharatiya Nayaya Sanhita, 2023.

Therefore to maintain the peace and tranquillity at the area you are requested to make it mandatory & circulate the order at your ward and help us to create an anti-social free area.

Your Co-operation is highly solicited in this matter.

ORDER

WHEREAS, from the reports received so far, there is sufficient ground to apprehend that the terrorists or anti-social elements may seek hideouts in the residential areas of the Police Stations, falling under metropolitan area of Bidhannagar Police Commissionerate,

AND

WHEREAS, there is every possibility of breach of peace and disturbance of public tranquility and also there is grave danger to human life and safety as well as injury to public property on that account,

AND

WHEREAS, it is selt necessary that some procedural safeguards should be put on tenancy or licensing process prevailing, so that terrorists or anti-social elements in the guise of tenants may not get tenancy or license for residential purpose and to cause disturbance or public tranquility or danger to human life or safety to public at large,

AND

WHEREAS, it is felt expedient to cause immediate prevention of those apprehended danger and arrange for speedy remedy thereof, in the interest of public tranquility, safety of human life, prevention of injury, annoyance to persons etc.,

Hence, in exercise of the power conferred by sub-section (1) read with sub-section (3) of section 163 of the Bharatiya Nagarik Suraksha Schhita, 2023 (Act. 46 of 2023), I, Mukesh, IPS, Commissioner of Police, Bidhannagar Police Commissionerate and Executive Magistrate in relation to the Metropolitan area of Bidhannagar Police Commissionerate and being empowered so to do by the State Government Home (Police) Department Order No. 96-PL/PB/4P-18/11 dated 05.01.2012 to act under the Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act. 46 of 2023), do hereby order that

- 1. No land-lord or owner or person whose property falls under the jurisdiction of area of any of the Police Stations under Bidhannagar Police Commissionerate area shall let/sublet/lease/rent out any residential accommodation or grant lease or license to any person unless and until the said landlord/owner/person has furnished the particulars of the said tenant(s)/ license as the case may be as per the Proforma in Schedule-I to the Officer-in-Charge of the Police Station concerned.
- whoever having property in his possession or under his management shall also inform in writing to the Officer-in-Charge of the Police Station concerned in whose jurisdiction the premise falls about the particulars of the tenants or leasee or licensee as the case may be as per the said proforma within 07 days of the tenant agreement.
- Any person contravening this order is liable to be punished under Section 223 of the Bharatiya Nayaya Sanhita, 2023.

AND

Whereas, the emergent nature of the case and circumstances do not permit serving of notice upon the general public in due time and hence, this order is passed ex-parte under sub-section (2) of section 163 B.N.S.S. and is directed to the public in general of this Commissionerate.

AND

This order will remain in force with effect from 16.01.2025 and shall be effective for a period of 60 days upta 16.03.2025 unless withdrawn earlier. It shall be published for the information of public, through Press and affixing copies in the prominent places i.e. on the Notice Boards of all Police Stations, Office premises of all Zonal ACsP, Divisional DCsP, Municipal Wards, Gram Panchayets in aforementioned PS areas under Bidhannagar Police Commissionerate and also make an announcement through Public Address System for the information of all goncerned.
